Shri Ashok Bhagat, Shri Atul Kantilal Nishar, and Prof. S.G. Deshmukh Member could not attend the meeting. A few members attended the meeting virtually.

Shri A.K. Gigoo, Assistant Registrar (Governance) was present to assist the Board.

At the outset, the Chairman, Board of Management (BoM), Prof. Nageshwar Rao, Vice Chancellor, IGNOU, welcomed all the members of the Board of Management. The Vice-Chancellor briefly narrated the significant developments in the university since the last BOM meeting.

i. Hon'ble Minister of Education, **Shri Dharmendra Pradhan** has addressed virtually as Chief Guest in the Foundation Stone ceremony for the construction of the Regional Centre Buildings at Bangalore, Pune and Noida on 19th September 2021.

- ii. **Shri K. Sanjay Murthy** has joined as New Secretary (Higher Education) on 1st October, 2021. The Board Welcomes the New Secretary and seeks his valuable support and guidance in IGNOU's march towards progress. **Shri Amit Khare**, Former Secretary MOE and I&B was also felicitated by the university as he is appointed as Advisor to the Prime Minister in PMO on 12th October, 2021. Further, the valuable support and guidance of **Shri Amit Khare**, Secretary, MOE and I&B who superannuated on 30th September 2021, was also acknowledged. His support and guidance was very encouraging to the University.
- iii. The Secretary of Higher Education, Ministry of Education Shri K Sanjay Murthy, Additional Secretary, Ministry of Education Dr. Vineet Joshi and Economic Advisor Mr. Mrutyunjay Behera visited IGNOU on 16th October 2021. A presentation on IGNOU's Road-map for the ODL/DE Learners and it's repositioning in-line with NEP-2020 was made. After this presentation, the MOE officials had discussed the issues relating to implementation plan of NEP-2020. Secretary, MOE has given useful inputs and directions to improve the implementation plan. He has also advised to set yearly targets for NEP Implementation. They had also seen the activities of Electronic Media Production Centre (EMPC).
- iv. IGNOU signed a Memorandum of Agreement (MOA) with Guyana Online Academy of Learning (GOAL) on 1st October 2021. This will enable the university to offer ODL and Online Programmes through Guyana Online Academy of Learning (GOAL) to the students of the Republic of Guyana. This MOA was the initiative, support and guidance of Dr. K. J. Srinivasa, High Commissioner of India at Georgetown, Guyana and the Ministry of External Affairs (MEA). The signing ceremony was conducted virtually and had the presence of key officials from both the institutions including Minister of Public Service, Honourable Sonia Parag and GOAL Director, Prof. Jacob Opadeyi.

Vice-Chancellor in his address said that, this would help the university's international footprint to expand. He also further expressed his sincere gratitude to the Honourable Minister of Ministry of Education, Skill Development and Entrepreneurship, **Shri Dharmendra Pradhan** Ji for all his encouragement in this endeavour.

v. The first phase of selection and recruitment process of the teaching positions of the University is completed on 11th October 2021. These teaching positions were advertised in October 2019. The team of the Academic Coordination Division completed the colossal task with their earnest efforts, which is appreciable. Director (ACD), Dr. Dev Kant

Rao deserves special compliments for his dedication and sincere efforts. The Board also complimented the ACD Team.

- vi. The Ministry of Education vide letter no.5-1/2019-L-I dated 28th September 2021, given the additional charge of the Post of Director, Central Hindi Directorate, New Delhi to the Vice-Chancellor, IGNOU. The Vice-Chancellor, assumed the additional charge from 29th September 2021.
- vii. Connect with Alumni is strengthened as Director (RSD) and his whole team is organsing virtual alumni meets for different regional centres on every Sunday. As on date, 10 such meets are organized and more than 15000 learners are registered on Online Alumni Portal.
- viii. Admissions for different courses are going on. On 25th October 2020 the status of admissions is as follows:

Fresh Registration - 4,28,229 Re-registration - 3,57,916.

In MBA programme, the enrolment has increased to 8,400 as compared to earlier July 2020 of around 2000.

- ix. The results of exams conducted in Aug-Sept. 2021 are being declared expeditiously. Around 90% of the results were declared. The result processing work of all regional evaluation centres except Patna Regional Evaluation Centre is satisfactory.
- x. STRIDE is making sincere efforts in conducting faculty development programmes for all the newly joined faculty.

Prof. V.S. Prasad congratulated the Vice Chancellor for undertaking above stated activities and appreciated the efforts being made by the University in this regard. Prof. K.K. Aggarwal also applauded the role of University in increasing the GER of the nation. He felt that university should play a leading role in the implementation of NEP.

BM 145.4.1 The Board ratified the action taken by the Vice Chancellor in accepting the request of Shri Girija Shankar, Dy. Director, P&DD for voluntary retirement from the services of the University by waiving off the shortfall in notice period.

- BM 145.5.1 The Board noted the status report on the grievances received and disposed off on PG Portal and iGRAM Portal (Appendix-3). Three vigilance cases were closed during the last two months. Regarding vigilance cases the Board also noted the circular No.08/12/14, dated 3rd December 2014 (Appendix-4) regarding second stage consultation with CVC in disciplinary cases. There is no parliamentary assurance case pending in the university.

TO CONSIDER THE PROPOSAL OF UNIGRAD EDUCATION CENTRE, BAHRAIN FOR AN OVERSEAS STUDY CENTRE OF THE UNIVERSITY

BM 145.7.1 The Board was informed that a proposal was received from UniGrad Education Centre, Bahrain for an Overseas Study Centre (OSC) of the University in Bahrain. The Board noted that the Institute is having license from the Kingdom of Bahrain. The Institute offers undergraduate, post-graduate, PG diploma and certificate programmes. The Indian diaspora in the region is 2.5 lakh, however total expatriates are 5.17 lakh. It was further informed that a confirmation had also been received from the Indian Embassy, Bahrain apprising the improved ICT and library facilities at the Centre.

BM 145.7.2 The Board approved the proposal for an Overseas Study Centre at UniGrad Education Centre, Bahrain.

ITEM NO. 8 TO CONSIDER THE INSTITUTIONAL DEVELOPMENT PLAN OF THE INDIRA GANDHI NATIONAL OPEN UNIVERSITY 2030

BM 145.8.1 The Item was taken up for consideration. It was informed that the National Education Policy 2020 (NEP 2020) envisages an Institutional Development Plan (IDP) that will serve as a vision document to guide the institutional transformation. The Institutional Plan needs to be aligned with the goals set forth in the NEP 2020 to achieve the intended objectives. The NEP 2020 notes that "Each institution will make a Strategic Institutional Development Plan on the basis of which institutions will develop initiatives, assess their own progress, and reach the goals set therein, which could then become the basis for further public funding.

It was further informed that the Board of Management in its 142nd meeting held on 31.05.2021 resolved for evolving an Institutional Development Plan (IDP) viz., Action Plan, Strategic, and Vision Plan, which may be developed by the CIQA of the University in consultation with Planning Board as vision for youth, as is also envisaged in the NEP. Accordingly, a Committee was constituted by the Vice Chancellor. The inputs received from the Committee members were compiled by CIQA and a draft IDP of IGNOU 2030 was prepared, which was circulated to the members of the Board of Management and Planning Board; academic and administrative staff

University for their valuable inputs/suggestions. The the suggestions that were received from Prof. VS Prasad, BOM member and other stakeholders were incorporated in the document. Further, in accordance with the resolution of the 49th meeting of the Planning Board, the draft 'Institutional Development Plan of IGNOU 2030' was again vetted. A meeting was also held on 01.10.2021, under Chairpersonship of the Vice- Chancellor to discuss and obtain suggestions on "IDP of IGNOU 2030". As per the resolution of the meeting CIQA invited strategic plans for the next five years from all Schools/Divisions/Centres/Cell/Unit/Institute and relevant suggestions were incorporated in the IDP document after discussion with the IDP committee members. The plan has also included the inputs received from Secretary, Higher Education, MOE, when the plan was presented before the Secretary on 16th October 2021.

- BM 145.8.2 Prof. Manjulika Srivastava, Director (CIQA) was invited to present the Power-Point Presentation on the Institutional Development Plan 2030 of the University.
- BM 145.8.3 After the presentation, Prof. V.S. Prasad appreciated the efforts being made by the University for preparing IDP 2030 for the overall development of the University. He observed that measures should be taken to enhance admission to meet the goals envisaged in the IDP 2030 and emphasized on mobilization of infrastructure, physical resources and human resources. He said that plan is dynamic in nature and university should ensure mechanisms for having its strategies in the light of the thrust of NEP. He stressed to put in place the Monitoring System for implementation of IDP and suggest the Multiple Parallel Implementation Steps in this regard.

While endorsing the observations of Prof. V.S. Prasad, Prof. K.K. Aggarwal was of the view that the IDP 2030 documents should also be presented in book shape for academic purpose. It may also be used as a case study for other Universities. Dr. P. Prakash also emphasized that IDP format should be designed to have sustainable development for reaching the un-reached. Hard copies of the plan were also sent to the members to get their additional comments, if any.

BM 145.8.4 After detailed deliberations, the Board approved the Institutional Development Plan of the University.

BM 145.11.2 The Board confirmed this Item for implementation and directed that Promotion Orders under CAS be issued accordingly. The Board also directed to issue the Part-Minutes in this regard.

- ITEM NO. 12 TO CONSIDER ADOPTION OF COVERAGE UNDER CCS (PENSION) RULES, 1972 IN LIEU OF NATIONAL PENSION SCHEME (NPS) FOR THOSE UNIVERSITY EMPLOYEES WHO WERE DECLARED SUCCESSFUL IN THE RESULTS DECLARED ON OR BEFORE 31.12.2003 AGAINST THE VACANCIES OCCURRING BEFORE 01.01.2004
- BM 145.12.1 The Board noted that the Department of Pension and Pensioners Welfare, Govt. of India vide its OM No. 57/04/2019-P&PW dated 17.02.2020, while considering the representations of such employees in whose case the selection process for recruitment was completed before 01.01.2004 but joined their service on or after 01.01.2004, decided that all such cases where the results for recruitment were declared before 01.01.2004 against the vacancies occurring on or before 31.12.2003, such candidates declared successful for recruitment shall be eligible for coverage under the CCS(Pension) Rules, 1972. Accordingly, such employees presently covered under NPS on their joining on or after 01.01.2004 may be given a one time option to be covered under the CCS (Pension) Rules, 1972, to be exercised by the concerned employee.

The University in order to examine the provisions made above, in relation to its employees, constituted a Committee which recommended to place the matter before the Board of Management for its consideration and after approval, notification to this effect be issued by the University inviting options from the eligible employees which may be examined/dealt with on case to case basis after adoption of the aforementioned OM (**Appendix-5**).

- BM 145.12.2 The Board adopted the Department of Pension and Pensioners Welfare, Govt. of India OM No.57/04/2019-P&PW dated 17.02.2020 and approved the recommendations of the aforesaid Committee.
- ITEM NO. 13 TO **CONSIDER** THE **IMPLEMENTATION** OF **CCS** (IMPLEMENTATION OF NPS) RULES 2021 FOR AVAILING BENEFITS UNDER THE NATIONAL PENSION SCHEME (NPS) OR UNDER THE CCS (PENSION) RULES 1972 OR THE CCS (EXTRAORDINARY PENSION) RULES 1939 IN CASE OF **DEATH DISCHARGE** ON OR INVALIDATION OR DISABILITY OF UNIVERSITY EMPLOYEE/SUBSCRIBER **DURING SERVICE**
- **BM 145.13.1** The Board was informed that the Department of Pension & Pension's Welfare has framed Central Civil Services (Implementation of

National Pension Scheme) Rules, 2021 vide GSR 227 (E) dated 30.03.2021 regulating the service matters of employees covered under the National Pension Scheme system (NPS) which provides for options to be exercised by such employees/dependants in case of death or discharge on invalidation or disability of subscriber during service for availing the benefits under the NPS or CCS (Pension) Rules,1972 or CCS(Extraordinary Pension) Rules 1939, as the case may be.

The University had constituted a Committee to examine the provisions made above, in relation to IGNOU employees. The Committee recommended that the provisions made above may be adopted by the Board of Management for those officials of the University who are/will be appointed on regular basis against the sanctioned posts and are availing the benefits of National Pension Scheme. With regard to regular employees who were covered under the NPS at IGNOU and who have died since issue of the above mentioned Rules, 2021, their claims/cases for coverage under CCS (Pension) Rules 1972 of the CCS (Extraordinary Pension) Rules 1939 may be examined/dealt with on case to case basis after adoption of the aforementioned rules (**Appendix-6**).

The Board also advised that the financial implications of this circular be also assessed.

- BM 145.13.2 The Board while considering the Central Civil Services (Implementation of National Pension Scheme) Rules, 2021 framed by the Department of Pension & Pensioners Welfare vide GSR 227 (E) dated 30.03.2021 approved the recommendations of the aforesaid Committee.
- **BM 145.13.3** Regarding pending cases with respect to counting of past services, the Board further directed that all pending and new cases in the University be strictly dealt with in accordance with UGC/DOPT Rules.
- ITEM NO. 14 TO CONSIDER THE STATUS OF RECRUITMENT TO TEACHING POSTS ADVERTISED BY THE UNIVERSITY IN SEPTEMBER/OCTOBER 2019 ALONGWITH STATUS OF BACKLOG VACANCIES FOR SC/ST/OBC/EWS ETC.
- BM 145.14.1 The Item was taken up for consideration. The Board noted the current status of recruitment process against teaching posts advertised in September/October 2019. The Board was informed that the Govt of India, Ministry of Education vide their letter F.No.15-4/2020-TC dated 8th October 2021 and Secretary Higher Education, MoE vide their D.O.

No.33-2/2021-TS-III (Pt.I) dated 24th August 2021 has desired to include an agenda item in every Finance Committee/Board of Governors/Board of Management meeting giving status of action taken with respect to backlog faculty positions lying vacant especially in Scheduled caste, Scheduled Tribes, Other backward Classes and EWS category in Central Higher Education Institutions functioning under the administrative control of the Ministry of Education. Accordingly the status of filling up of backlog vacancies for SC/ST/OBC/EWS in teaching posts was placed before the Board (Appendix-7). The Chairman informed that backlog vacancies were also arisen as the University could not fill up the vacant positions due to non-availability of the regular Vice Chancellor and later on non-availability of minimum required candidates to be called for interview.

- BM 145.14.2 The Chairman further informed that there are also certain teaching positions relating to engineering and agriculture lying vacant as there are restrictions in running some courses by AICTE and UGC. Further, positions of a few disciplines were not filled as they have very low enrolment. These positions may be adjusted against other disciplines which are to be promoted/strengthened as per the emerging requirements of NEP-2020. It was further informed that no eligible EWS applications were received against the positions of Professor and Associate Professor.
- BM 145.14.3 The Board noted the status of filling up of backlog vacancies for SC/ST/OBC/EWS in teaching posts and directed to advertise/readvertise the posts as per requirement.
- ITEM NO. 15 TO CONSIDER THE STRATEGY FOR PROMOTING THE ONLINE PROGRAMMES OF THE UNIVERSITY OUTSIDE INDIA
- BM 145.15.1 It was informed that the National Education Policy 2020(NEP 2020) of Government of India emphasizes on internationalization of higher education to meet the requirements of 21st century. The IGNOU being a National Open University is committed towards internationalisation of higher education in qualitative and equitable manner. Also, keeping in view the exemption given by the UGC from the purview of UGC ODL Regulations and UGC Online Regulations, the University may now offer its online programmes outside India. It was further informed that to formulate the strategy for promoting the online programmes outside India, a Committee was constituted by the Vice Chancellor to define the roles and responsibilities of the Overseas Facilitator for promoting the online programmes in their respective

country and facilitating admissions of learners in online programmes. The Committee has submitted its observations made in its 1st meeting held on 7.9.2021 (**Appendix-8**). The Board noted brief recommendations of the Committee, as under:

- 1. The Overseas Facilitator/Promotional Partner should provide preadmission counseling to the prospective students interested in joining the University's online programme and facilitate in their admission online through the University's portal.
- 2. The Overseas Facilitator/Promotional Partner shall be responsible for providing post-admission counseling to the online students and for taking up various student related issues on day-to-day basis with the University.
- 3. The Partner should possess IT infrastructure and office space to facilitate the students for online counseling, assignment submission, project submission, online examination etc. where required.
- 4. The full programme fees of online international student shall be credited in IGNOU's account and its 25% share shall be released to the Overseas Facilitator on production of an invoice subject to satisfactory performance.
- 5. Student Registration Division shall maintain software for admission of international student for online programme and each Overseas Facilitator/Promotional Partner shall be given a specific code.
- BM 145.15.2 During the deliberations, Prof. V.S. Prasad suggested that a Project Report be prepared to define different terms along with the role of different agencies and the related processes. The role of different agencies should be explored for enhancing the enrolment and student counseling. It was also suggested that active participation of the International Study Centres in promoting the online programmes abroad be encouraged.
- **BM 145.15.3** After detailed deliberations, the Board approved the proposal for promoting the Online Programmes of the University outside India.
- TO CONSIDER THE MATTER RELATED TO JOINING OF DR. RAMMURTI MEENA, ASSISTANT REGIONAL DIRECTOR, IGNOU ON REPATRIATION FROM NCTE, JAIPUR
- BM 145.16.1 The Board noted the joining of duty in the University by Dr. Rammurti Meena, Assistant Regional Director on repatriation from NCTE, Jaipur w.e.f. 11.10.2021.

TO CONSIDER THE STATUS OF ACTIVITIES UNDERTAKEN BY SCHOOLS AND THE PRESENTATIONS MADE BY THE SCHOOLS OF SOCIAL SCIENCES (SOSS) AND SCHOOL OF COMPUTER AND INFORMATION SCIENCES (SOCIS)

BM 145.17.1 The Directors of School of Social Sciences, Prof. Rashmi Sinha and School of Computer & Information Sciences, Prof. P.V. Suresh made their presentations before the Board regarding the current and future activities undertaken by the Schools which were well appreciated by the members. The Board also noted the Status of academic activities undertaken by the Schools of Studies.

BM 145.17.2 Prof. K.K. Aggarwal suggested that increase in the duration of BCA programme from 3 to 4 years may be reexamined being area specific studies. He further suggested that the School of Social Sciences should develop sustainable modules in mixed modes and also develop single mode programmes.

Prof. V.S. Prasad was of the view that the basic academic programmes of the IGNOU should be course based instead of programme centric. The courses should be developed not only for the enrolled student but also for the students appearing for competitive exams.

The Board noted the above observations/suggestions of the members and agreed to the same.

ITEM NO. 18 TO CONSIDER DISCONTINUATION OF THE FUNCTIONING OF NON-OPERATIONAL GYAN VANI FM RADIO STATIONS

BM 145.18.1 The Board was informed that IGNOU was made the nodal organization by MHRD to establish and operate Educational FM Radio Stations of 10 KW transmitting power at 37 locations as per license agreement for a period of ten years with the Ministry of Information and Broadcasting (MIB) in 2001. Grant of Permission Agreement (GOPA) was signed between Ministry of I&B and IGNOU to revive 10 KW FM Educational Radio Stations at 37 cities on 19.2.2016 and the validity of the GOPA was for 15 years. Accordingly, an MOU was signed on 9.12.2016 with Prasar Baharti to continue to use their existing transmission infrastructure at 37 places through the payment of an annual license free of Rs.889.82 lakhs approx. which would cover the operational cost of GV transmitter and also the rental for the space, tower etc. After signing of these agreements, IGNOU could revive operations of only 15 FM stations out of 37 that too at much lower operating power than 10 KW capacity of each transmitter. However, IGNOU has to keep paying the license fee to Prasar Bharati and wireless operating license (WOL) fee to Ministry of Communication and IT as per the MOU despite GV Stations lying Non-functional.

It was further informed that these issues were discussed in Joint Coordination Committee with Prasar Bharati on 22.1.2020 and it was decided to withdraw non-operational transmitter equipment from AIR premises in phased manner after clearing all pending dues. This matter was placed before the Board of Management at the 139th meeting held on 17. 3. 2020 to discontinue and surrender 22 wireless operating licenses of Gyan Vani stations wherever transmitters have become non-operational and could not be replaced immediately. The Board suggested that requirements of financial assistance be placed before the Ministry. IGNOU has requested the Ministry for financial support. The university could not get any additional financial support. Further, based on the recommendations of the Gyan Vani Review Committee, constituted for the purpose; IGNOU had surrendered the permission to operate 17 non-operational Gyan Vani stations to Ministry of I&B in July 2020. Prasar Bharati vide letter dt.22.10.2020 also requested IGNOU to initiate removal of complete installations at 17 stations. IGNOU has also stopped payment of license fee for these 17 stations and closed Bank accounts. In view of the above, Gyan Vani Review Committee was constituted by the Vice-Chancellor to examine the status of the GV stations and to suggest continuation or surrender of the same. Based on the recommendations of the review committee IGNOU had surrendered the permission to operate 17 non-operational GyanVani Stations to Ministry of Information and Broadcasting in July 2020. The matter was reported to Ministries of Education, I & B and Prasar Bharati. Prasar Bharati, vide letter dated 22.10.2020 endorsed this decision and requested IGNOU to initiate removal of complete installations at 17 stations. IGNOU has stopped payment of license fee @ an average of Rs. 13 lakhs for each of these 17 stations for operations and maintenance (O&M). Bank accounts of these 17 stations have been closed.

The reach of these Gyan Vani stations are limited and in audio mode only. Support from *Gyan Darshan* and *Swayam Prabha* channels are more effective. IGNOU presently has four Swayam Prabha DTH channels and one *Gyan Darshan* channel. *Swayam Prabha* channels are free of any cost to IGNOU provided by the Ministry. These channels along with *Gyan Darshan* have both audio and visual effects and have wider reach.

It was observed that IGNOU made efforts to continue the operation of the rest of 20 Gyan Vani Stations, however, transmitter equipment of these stations could not be maintained due to lack of support from OEMs for AMCs and repairing these equipments through third party resulting GV stations uneconomical, in were operational/working at very low power. Again the current status of these remaining 20 GV stations was presented to the newly constituted Gyan Vani Review Committee on 27.9.2021. The Committee suggested that eight Gyan Vani stations that are non-operational have to be surrendered to the Ministry and transmitter infrastructure may be withdrawn from AIR premises. It was also suggested that in order to stop the annual payment of 3.52 crores by IGNOU to AIR it was necessary to clear the site occupied by the non working infrastructure as per MOU signed with Prasar Bharati and so another Committee namely "Gyan Vani Non-working Infrastructure Disposal Committee" was constituted to decide on action to be taken to remove equipment from AIR premises. The Committee recommended as under:

- 1. To surrender the wireless operating license (WOL) of the eight GV stations
- 2. To take over the GV assets from AIR premises by clearing outstanding dues as per the MoU and e-auction all obsolete transmitter equipment following due procedure.
- BM 145.18.2 After detailed deliberations, the Board approved the recommendations of the committee for discontinuation of the functioning of eight Non-Operational Gyan Vani FM Radio Stations including Patna (in addition to earlier discontinued 17 Gyan Vani stations) and directed to take further necessary action in the matter.
- TO CONSIDER THE PROPOSAL FOR RECRUITMENT OF FRESH AND BACKLOG POSTS OF JUNIOR-ASSISTANT-CUM-TYPIST (JAT) AND OTHERS THROUGH NATIONAL TESTING AGENCY (NTA)
- BM 145.19.1 The Item was taken up for consideration. The Secretary informed that the University could not make any recruitment in the case of non-academic employees since long even though more than 200 employees have left the University in the last five years on superannuation & other reasons. Those having been recruited in the feeder cadres in the past have already been promoted to the next higher level as provided under R&P Rules, 2010 resulting in shortage of regular staff at the lowest level of the hierarchy. Overall there are 500 positions lying vacant in Group-C and 100 positions in Group-B including around 10

backlog vacancies. As regards JATs, total sanctioned strength i.e. 425 against which 83 are filled in, leaving a vacancy of 342 and majority of filled in JATs are under consideration for promotion. This has made the routine functioning of the University somewhat difficult due to over dependence on contractual staff. In addition, some more Regional Centres have also been created which remain regular manpower deficient and also intake of students both fresh & re-registration has increased manifold during the last 10 years.

It was informed that the Board of Management in its 139th meeting while considering the proposal of outsourcing the conduct of written examination for the post of Assistant Registrar, Security Officer and JAT approved that the process of conduct of written examination be done through National Testing Agency (NTA). The NTA has conducted the written test for recruitment to the posts of Assistant Registrar and Security Officer on 24.1.2021, result of which was declared on 16.6.2021.

- BM 145.19.2 It was therefore proposed that the process of direct recruitment of vacant posts including backlog vacancies of JAT's & other cadres may be initiated by the University which may be out sourced to National Testing Agency (NTA) which includes conduct of skill test and interviews etc., if any. The syllabus for the recruitment examination will be finalized by the NTA in consultation with the University. If the proposal is considered, the University may go ahead with 100 vacant posts plus backlog vacancies under direct recruitment quota.
- **BM 145.19.3** The Board approved the proposal for recruitment of fresh and backlog posts of JATs and other cadres through NTA.
