**Regarding Item 12:** The Board suggested to reduce the number of experts to 8-10 names only and authorized the **Chairperson** to reconstitute the expert committee in consultation with the **discipline**. It was agreed to circulate the revised list with the minutes

**Regarding Item No 26:** "The School Board member .......... list of evaluators of **FST-01** as he is not suitably qualified to evaluate the course.

Except Mr Junka Das, whose name was not approved as evaluator for FST-01 all the other ....... Board members."

- Item No. 2: To approve the minutes of the first meeting of the School Board Standing Committee of the School of Sciences held on 6<sup>th</sup> July, 2012 and to note the action taken thereon.
- SB 45.2.1 The minutes were approved and the action taken was noted.
- Item No. 3: To approve the minutes of the second meeting of the School Board Standing Committee of the School of Sciences held on 5<sup>th</sup> September, 2012.
- SB 45.3.1 The minutes were approved.
- Item No. 4: Matters arising from the minutes.
- SB 45.4.1 The Board suggested the following addition in the recording of item no 4 in the minutes of the 44<sup>th</sup> School Board, and the recording would now read as:

"The School Board members agreed to constitute the Standing Committee and agreed that henceforth, all such matters will first be deliberated in the School Board Standing Committee (SBSC) meeting and become part of the reporting items for the School Board. The Standing Committee will be chaired by the Chairperson of the School Board and will consist of one member from each discipline represented in the School Board. If any member of the Standing Committee is not able to attend the meeting due to being on leave or prior commitment, the next senior most member of the discipline would be invited as special invitee to attend in her/his

**place.** The Standing Committee is authorized to include subject experts as Special Invitees as and when required. The term of the committee will be for two years."

SB 45.4.2 Regarding item no 2 of the 1<sup>st</sup> SBSC Prof Vijayshri requested that a complete list of Ph.D. scholars registered with the School of Sciences be provided to the School Board. It was agreed that the list will be requested from the Research Unit.

## Item No. 5: To consider and approve the names of the external members to be co-opted to the School Board of the School of Sciences under Clause (2)(e) of Statute 10 A.

The Board agreed that since there are now 8 disciplines in the School and provision for co-opting only 5 external members under Clause (2)(e) of Statute 10 A, two external members would be co-opted from the names suggested by the earlier disciplines of the School, namely Chemistry, Physics, Life Sciences and Mathematics; 2 members would be co-opted from the names suggested by the new disciplines of the School. The disciplines to be represented would be taken up in alphabetical order and the fifth member would be co-opted from either disciplines through rotation. The disciplines that remain unrepresented would invite special invitees to the School Board as and when required from the names approved in the given list. The Life Sciences discipline would suggest one more name to be added to the existing list and Chemistry discipline added the name of Prof. Gurmeet Singh Department of Chemistry, Delhi University.
