1. THE UNIVERSITY

Indira Gandhi National Open University (IGNOU) was established in September, 1985 by an Act of Parliament, with a view to democratise education, so that it covers large segments of population, vocations and professions. The primary emphasis is on innovation, flexibility and cost effectiveness. Thus, it is a university with a difference.

1.1 The major objectives of the university are:

- To promote the educational well-being of the community,
- To democratise higher education by providing easy access to all those who desire to improve their qualifications, skills and competence by taking education to the doorsteps of people living even in remote and rural areas,
- To disseminate learning and knowledge through an innovative multi-media teaching-learning system, to provide high quality education at all levels,
- To coordinate and determine the standards of Distance Education and Open University Systems throughout the country.

1.2 The salient features of this system of education are:

- Study according to your own pace and convenience,
- Study at your own chosen place,
- Flexibility in choosing courses and combination of courses from a wide range of disciplines/ subjects, and
- Use of modern and appropriate educational and communication technology.

Student support services are provided by the University through a network of study centres scattered all over the country. Study centres are the actual focal points to enable you to receive regular information and learning support. Each study centre provides you with library, audio and video facilities to further help you in the learning process. Senior and experienced academics are engaged in face- to-face counseling at study centres. The study centres are generally located 'in existing educational institutions and normally function on all holidays and Sundays and also in the evenings on working days. Each study centre is supervised by a

Coordinator. Regional centres have been set up in different parts of the country to coordinate the functioning of study centres.

2. THE SCHOOL OF SOCIAL WORK

The School of Social Work (SOSW) at Indira Gandhi National Open University (IGNOU) was established in 2007. It aims at providing quality education in the areas of Social Work, HIV/AIDS, counselling, tribal studies and family studies by offering programmes from Certificate to Doctoral Degree.

The SOSW at IGNOU is the first School of Social work offering social work programmes in ODL mode. It is the first school of Social Work in India to take social work education to all the States and Union Territories in the country as well as to SAARC and African nations. It has indigenously developed high quality Self Instructional Materials (SIM) and uses multi-media approach for imparting social work teaching and training both in English and Hindi. It offers social work programmes to in-service learners and engages a large number of practitioners for field work supervision.

2.1 Vision

To provide inclusive and quality education in social work across the country and beyond the borders.

2.2 Mission

To provide quality education through open and distance learning using multi-pronged strategies and services to reach the unreached with an emphasis on social work values and ethics whereby improving the services in social welfare sectors.

2.3 Objectives of SOSW

- To promote human resources aiming at improving the quality of life of poorest of the poor.
- To meet the growing demand for professionally trained social workers across the country.

- To provide social work education and training based on indigenous knowledge and uniform curriculum across the country.
- To help the learner acquire professional skills and knowledge to help the clients to deal with their emotional and psychological problems.
- To help the learner acquire professional skills and develop capacity in helping people to solve various social and economic problems.
- To help the learner to develop required attitudes in understanding people's problem solving interventions.

3. SALIENT FEATURES OF PH.D PROGRAMME

The PhD programme at IGNOU was started in 2008 when other programmes of the school were initiated. Till now 21 scholars were successfully awarded doctoral.

- a) Unlike other programmes in IGNOU, the Ph.D programme is offered in **Offline/Regular mode** where the scholars get the opportunity to regularly interact with their Ph.D supervisors and receive regular mentoring and guidance.
- b) The course work is structured in such a way as to provide an in-depth understanding on the social work theory and practice and a strong foundation on research methods and statistical applications.
- c) The scholars are trained in their specific research area and they get an opportunity to do a mini study during the course work.

4. PROGRAMME STRUCTURE

The University follows the credit system for its Ph.D Programme. Each credit amounts to 30 hours of study comprising all learning activities. Thus, a 4 credit course involves 120 study hours, a 6 credit course involves 180 study hours and 10 credit course involves 300 study hours. To successfully complete the Ph.D programme you have to earn 18 credits.

The Ph.D Programme in Social Work has 4 courses and all are compulsory.

3. To get informed about the open access publishing and to create awareness of publication misconduct.
4. To understand the publishing databases, research metrics and the processes involved in the standard publication.

6. SCHOLARS FORUM

Ph.D programme is an intensive research activity carried out by the School of Social Work. The programme aims to enhance the research skill and knowledge of the research scholars. The scholars need research aptitude and knowledge from various discipline related to Social Work and the societal problems. Moreover, apart from the theoretical knowledge the scholars also need to interact with the field practitioners to gain knowledge on the implementation aspects and know the gray areas where research is required. This will help the candidates to identify the research gaps and conduct need based study.

To make this possible the scholars need a platform to enhance the research skill and knowledge. Therefore, this Social Work Scholar's Forum was initiated by School of Social Work, IGNOU in the academic year 2023-24 with the support of the Dr. Saumya, Director of SOSW and all faculty members. Dr. Dilip Diwakar G, Research Programme coordinator has taken the responsibility to facilitate the Scholar's Forum activities. This forum provides a platform for the scholars to interact with various practitioners and academicians involved in field research. It also provides an opportunity to our scholars to listen, interact and discuss with academicians and practitioners. We believe this will help them to gain insight and enrich their knowledge.

The scholars will take key role in this forum in identification of the resource person from inside and outside IGNOU, invite them for the discussion on every Wednesday, they initiative will be carried out under the guidance and supervision of the Research Programme Coordinator. The Director of the School and all other faculties have agreed to help and support the scholars for successfully running this forum and they will guide them to identify

the suitable resource person.

This academic forums creates a collaborative environment where ideas will be nurtured, challenges will be discussed to bring out new innovative ideas and practice. It is believed that such interactions are not only enrich the individual academic journeys but also contribute to the collective advancement in respective fields. This forum further helps to create good communication with various experts to learn and to strengthen the social workers 'commitment.

7. GENERAL INFORMATION

- a) The process and schedule of registration shall be prepared and announced by IGNOU in accordance with the guidelines given by the Research Council from time to time.
Research Unit/ Research Coordination Division (RCD) shall be responsible for the overall coordination of the Research Degree Programme of the University.
- b) The Ph D Programme is offered in strict compliance with the UGC (Minimum Standards and Procedures for award of Ph.D Degree) Regulations, 2022 and amendments there to from time to time.
- c) Selected candidates will be governed by IGNOU Ordinance/IGNOU regulation/ Guidelines for conduct of Ph.D Degree Programmes.
- d) Admission to the Ph.D Degree Programmes is strictly on merit, based on the performance in the Entrance Test and Interview. For the academic session 2023-24 cycle there is no written test, candidates cleared UGC NET/JRF will be called for the interview directly (this is subject to change as per UGC directions/notification).
- e) IGNOU offers Ph.D programme under two categories: Part time and Full time. Both categories of students will be required to attend course work with 80% attendance to complete the course successfully.
- f) In case a candidate does not meet minimum eligibility criteria and appears in the entrance test/interview, it is at the candidates own risk and cost and if at any stage, it is found that the minimum eligibility criteria requirements are not fulfilled, the admission,

if granted, shall be cancelled ipso facto.

- g) The Ph.D programme involves coursework during the first six months of admission, which will be conducted in IGNOU Campus at New Delhi only. A student has to attend the coursework on a regular basis. At least 80 per cent attendance is compulsory.
- h) As of now, IGNOU does not have hostel facilities for students. Students have to make their own arrangements for stay in Delhi.

8. GENERAL ELIGIBILITY CRITERIA FOR PH.D.

The eligibility criteria for admission to Ph.D programme are as follows:

- a) Master's Degree in Social Work from a University recognized by UGC with at least 55% marks [50%marks in the case of SC, ST and OBC (Non-creamy Layer)/Differently-Abled, EWS and other categories of candidates as per the decision of UGC from time to time, or for those who had obtained their Master's Degree prior to 19th September, 1991] excluding grace marks.

9. SELECTION PROCEDURE

9.1 Stage 1: Entrance Test (for the admission cycle 2023- 2024, there is no entrance examination, only candidates having NET/Fellowship will be called for interview- it is subjected to change as per UGC notification)

- a) In general, the Entrance Test will be conducted by the University across the country. The list of eligible candidates to appear for the Entrance Test will be displayed on IGNOU website.
- b) No separate communication shall be sent to candidates in this regard.
- c) Hall Tickets enabling the candidates to take the Entrance Test will also be displayed on IGNOU website. Candidates are required to download and print the same to appear in the Entrance Test.
- d) Candidates are required to bring with them an original identity proof having photograph, such as Aadhar Card, Voter ID Card, Driving License, Passport and ID Card issued by Govt. Agencies.

- e) The syllabus of the Entrance Test is as per the 'University Grants Commission (UGC (Minimum Standards and Procedures for award of Ph.D Degree) Regulations, 2022 comprising 50% on Research methodology and 50% on specific subject.
- f) The Entrance Test shall carry a weightage of 70% and 30% weightage shall be given to the interview/viva.
- g) Those who secure at least 50% marks in the Entrance Test (45% marks in case of SC/ST/OBC (Non Creamy layers) / Differently abled persons, EWS and other categories of candidates as per the decision of UGC from time to time will be shortlisted for the interview in order of merit subject to the maximum limit of five times of the available seats.

9.2 Stage 2: Interview/ Presentation

- a) Short-listed Candidates in the Entrance Test will be called for interview/presentation of Synopsis before the Discipline specific Doctoral Research Committee.
- b) The interview will assess the students knowledge on research methodology, subject specific knowledge and research proposal.
- c) Offer letters for admission will be sent to the Selected Candidates only.

10. DURATION OF THE STUDY

- a) The minimum and maximum duration of Ph.D programme is three years and six years respectively. The Women Candidates and Persons with Disabilities (40% or more / "severe" where percentage is not defined) are given two years extra in the maximum duration.

11. FEES STRUCTURE AND SCHEDULE OF PAYMENT

- b) The fee for the year 2024 is Rs. 16,800/- (subjected to change). Fee and other details will be notified in the Ph.D advertisement every year on the university website.

12. COURSE WORK

- a) Course work is compulsory for all the candidates registered for the Ph.D programme. It

will be conducted offline in the campus.

- b) The course work shall be completed within a maximum period of 2 semesters from the date of the commencement of the academic session the student has been admitted to in accordance with the Guidelines prescribed from time to time by the Research Council and in conformity with the UGC (Minimum Standards and Procedure for Award of M.Phil/Ph.D. Degree) Regulations, 2016. If a student fails to complete coursework within prescribed time period, his/her admission/ registration shall be cancelled automatically.

13. MEDIUM OF INSTRUCTION

- a) English will be the medium of instruction.

14. EVALUATION

- a) The evaluation of the Pre-PhD course work will be done in accordance with the evaluation methodology provided in the IGNOU Guidelines for MPhil/PhD Programmes approved by the Research Council in consonance with UGC Regulations, 2016 and as amended from time to time.

15. PROGRESS OF RESEARCH STUDENT

Commencing from the date of registration, a student shall submit progress report periodically (once in six months until pre-submission seminar) in the prescribed format to the supervisor(s) who shall forward the same along with his or her detailed assessment of the work to the School Board through Doctoral Research Committee.
