Prof. Ramanujam, Director, STRIDE and Shri U.S.Tolia, Registrar, Administration attended the meeting as special invitees.

Dr. D.K.Choudhry, PVC, Prof. K.R.Srivathsan, PVC, Prof. Shafiq Parveen, Prof. Vijay Kapur, Prof. Srikrishna Deva Rao, Prof. Bimla Kapoor could not attend the meeting.

At the outset, the Chairman welcomed the members to the meeting. He specially welcomed the new Member Prof. P.Purushotam Rao who is attending the Research Council for the first time as one of its member. He also appreciated the contributions made by Prof. Vijay Shankar Dubey, (outgoing member) in deliberations of the Research Council's meetings. He then requested the Member-Secretary to present the items on the agenda of the meeting.

The following items were taken up:

**ITEM NO. 1 To confirm the Minutes of the 14<sup>th</sup> Meeting of the Research Council held on 23<sup>rd</sup> June, 2009 and note the action taken thereon.**

RC.15.1.1 It was presented that the Minutes of the Fourteenth Meeting of the Research Council held on 23<sup>rd</sup> June, 2009 were circulated to the members. Comments have been received from Prof. Parvin Sinclair, PVC one of the member of the Research Council which are re-produced as under:

**“Regarding RC 14.28.1, these candidates have not presented any research proposal. They have merely applied for the Ph.D programme, and based on their CSIR-UGC NET qualification, they have been admitted to the programme. Their research proposal will only come later, and would be placed before the Doctoral Committee concerned”.**

The names of these candidates are placed below:

The earlier recorded Minutes in this regard are placed in the Minutes of the 14<sup>th</sup> Research Council (Resolution No. 14.28.2 Annexure-1). The Action Taken Report on the Minutes was also annexed to the agenda and circulated to members.

RC.15.1.2 The Research Council confirmed the Minutes of its 14<sup>th</sup> Meeting held on 23<sup>rd</sup> June, 2009 alongwith the above comments (**Annexure-1 to item no. 1 as circulated with the agenda**) and noted the action taken thereon.

**ITEM NO.2 To ratify the action taken by the Vice Chancellor in approving the Course Work Component of Research Degree Programme in Distance Education leading to launch of M.Phil in Distance Education from January, 2010.**

RC.15.2.1 It was presented that based on the advise of the Area Committee on its meeting dated 14<sup>th</sup> May, 2007 and the subsequent Expert Committee meeting of M.Phil Course Work held on 4<sup>th</sup> January, 2008, the STRIDE faculty has developed the detailed M.Phil Programme course structure.

Hon'ble Vice Chancellor has approved the launch of the M.Phil in Distance Education programme from January, 2010 alongwith the course contents and strategies recommended by the Expert Committee.

RC.15.2.2 The Research Council ratified the action taken by the Vice Chancellor in approving the Course Work Component of M.Phil Degree Programme in Distance Education (**Annexure-1 to item no. 2 as circulated with the agenda**).

**ITEM NO.3 To ratify the action taken by the Vice Chancellor in approving the provisional registration of Mr. Tauquir Alam, RTA, SOFL.**

RC. 15.3.1 It was presented that Mr. Tauquir Alam, RTA was provisionally registered in Ph.D even though no Ph.D programme in Arabic by the School of Foreign Language was launched nor any faculty member was appointed at the time of his registration. The case of Mr. Tauquir Alam has been approved by the Doctoral Committee held on 12-9-2008 and subsequently by the 2<sup>nd</sup> School Board of SOFL held on 7-11-2008. The School Board of SOFL dated 23.6.2009 has also approved the M.Phil/Ph.D programmes in Arabic Language (**Annexure-1 to item no 3 as circulated with the agenda**). Mr. Tauquir Alam has already done his M.Phil and hence he comes under the **Category "A"** and he has also been exempted from the course work.

Based on the recommendations made by the Doctoral Committee and School Board, the Hon'ble Vice Chancellor has approved the provisional registration of Mr. Tauquir Alam, RTA, SOFL.

RC. 15.3.2 The Research Council ratified the action taken by the Vice Chancellor in approving the provisional registration of Mr. Tauquir Alam, RTA, SOFL.

**ITEM NO. 4 To ratify the action taken by the Vice Chancellor in approving the Integrated Research Degree Programme for Category "B" candidates.**

RC. 15.4.1 It was presented that Hon'ble Vice Chancellor had a meeting on 19.8.2009 with RTAs to review the research and teaching activities undertaken in their respective discipline. Each RTA attended the meeting was asked to present a brief on research and teaching they have undertaken so far. While presenting the facts of the work done, RTAs expressed that they are in the process of completing the Course Work. However, they will not be eligible for M.Phil degree as they have registered for Ph.D directly. RTAs also expressed that they would like to work additionally for M.Phil dissertation simultaneously while pursuing Ph.D.

Having listen to RTAs regarding the issue (as specified above), Hon'ble Vice Chancellor has agreed to allow RTAs to work for M.Phil dissertation additionally. Further, the Vice Chancellor had also directed the Director, Research Unit to work-out on the modalities. Accordingly, modalities are worked-out as given below:

### **Terms and Conditions:**

1. Optional for those who desire to work additionally for M.Phil dissertation for 12-16 credits.
2. Candidates are required to submit M.Phil dissertation between 6 months to 12 months after completing the Course Work successfully.
3. Rs. 3500/- will be charged additionally towards M.Phil Programme fee beside Programme fee Rs. 7000/- for the first year for Ph.D.
4. Evaluation of Course Work and Thesis of M.Phil and Viva-Voce will be done as per University Ordinances & Regulations, 2008 and subsequent notifications issued by the University.

Ph.D candidates registered under RTA scheme or others under Category 'B' with or without M.Phil after completing the Course Work will be allowed to pursue their research for thesis. The extra/additional work done for M.Phil dissertation will be counted only for M.Phil as he/she is opting additionally for M.Phil dissertation.

### **Award of M.Phil/Ph.D Degrees**

1. After completing successfully 32 to 36 Credits Course Work and 12 to 16 credits Dissertation, an M.Phil degree will be awarded.
2. After completing successfully 32-36 credits Course Work and 64 to 68 credits Thesis work, a Ph.D degree will be awarded (Category "B").
3. After completing successfully 64-68 credits thesis work for Ph.D, a Ph.D Degree will be awarded (Category "A").
4. After completing successfully 32-36 credits Course Work, 12-16 credits Thesis for M.Phil and 64-68 credits for Ph.D, an M.Phil and Ph.D Degrees will be awarded under the Integrated Research Degree Programme.

RC. 15.4.2 During the discussion, Prof. O.M. Mishra, PVC, Member suggested that the term "Category A or B" should not be used. Instead he suggested to identify suitable terminology for this purpose.

RC. 15.4.3 The Research Council ratified the action taken by the Vice Chancellor in approving the Integrated Research Degree Programme for Category "B" candidates.

**ITEM NO. 5 To ratify the action taken by the Vice Chancellor in approving the Eligibility criteria for Research Supervisor – an amendment to the Ordinance and Regulations of the University.**

RC 15.5.1 It was presented that as per the Ordinances and Regulations of the University, 2008 "All the Professors/Readers of IGNOU shall be eligible for the Research Supervisor-ship of the University" (Section 4 of 13 at page no. 59).

However, as per **clause 4.3** with regard to teachers and other academic staff, who are other than Professors and Readers (Lecturers/Assistant Directors and others), the eligibility criteria for the Research Supervisor is as follows:

**“An academic (includes teachers and other academic staff) with a Ph.D degree and with at least five years post-doctoral research and/or teaching experience shall be eligible to be recognized as a Research Supervisor” (Annexure-1).**

It is in this context, some of the faculties from different Schools have represented the matter in written and oral requesting the authorities to remove the condition of 5 years post-doctoral research/teaching experience. However, their contention is that Lecturers/Assistant Directors and other academics with a Ph.D degree alongwith 5 years teaching/research experience be allowed to be Research Supervisors.

Infact, many of the faculties who are in the category of Lecturer and Lecturer with Selection Grade and other Academics did their Ph.D while in service and got Ph.D degree. However, as per the present Ordinances and Regulations of the University they will not be eligible because of the condition that they should have 5 years teaching/post-doctoral research experience after getting Ph.D degree. Some of the Members of the Research Council even mentioned that some of the Lecturers/Sr. Lecturers have become Readers after completing successfully Ph.D while they were in service and they become straight-away eligible for research.

This amendment will facilitate number of faculties who have 5 years teaching/research experience with Ph.D are equally competent and enthusiastic to guide Ph.D/M.Phil candidates.

RC 15.5.2 After detailed deliberations, the Research Council agreed to offer research supervisorship to Lecturer, Sr. Lecturer, Assistant Directors and other academics those who have five years teaching experience with a Ph.D Degree.

A table showing the existing clause, proposed clause and clause after amendment is placed below:

RC 15.5.3 The Research Council ratified the action taken by the Vice Chancellor in approving the Eligibility criteria for Research Supervisorship – an amendment to the Ordinance and Regulations of the University.

**ITEM NO. 6 To ratify the action taken by the Vice Chancellor in approving the recognition of Dr. A. Murli Rao, Joint Director as Research Supervisor for Doctoral Programmes of IGNOU.**

RC 15.6.1 It was presented that Dr. A.Murali M.Rao, Joint Director, Computer Division has requested that his name may be considered for recognition as Research Supervisor for Doctoral Programmes of IGNOU in the area of Computer Science/Informatics/Information & Communication Technologies (ICT). Dr. A. Murli Rao has done Ph.D., M.Tech and B.Tech in pure Computer Science and having over 10 years of professional experience in Industry and University. His research area is System and Network Security. His brief bio-data was also annexed with the agenda.

Hon'ble Vice Chancellor has approved the name of Dr. A. Murli Rao, Joint Director as Research Supervisor for Ph.D programmes offered under ACIIL in the area of Computer Science/Informatics/Information & Communication Technology (ICT).

RC 15.6.2 The Research Council ratified the action taken by the Vice Chancellor in approving the recognition of Dr. A. Murli Rao, Joint Director as Research Supervisor under ACIIL in the area of Computer Science/Informatics/Information & Communication Technology (ICT).

**ITEM NO. 7 To ratify the action taken by the Vice Chancellor in approving the Internal Supervisor of Ms. Rekha Yadav and Mr. K.K.Soman, part-time Ph.D candidates seeking admission to Ph.D in Education.**

RC 15.7.1 It was presented that the research proposals of the following part-time Ph.D candidates seeking admission to Ph.D in Education were duly approved by the Ist Doctoral Committee dated 27.3.2009 and subsequently by the 28<sup>th</sup> School Board of School of Education held on 6.5.2009:

The School Board of SOE has also approved the names of the supervisors (external) mentioned above. Based on the recommendations made by the Doctoral Committee and School Board of SOE, the 14<sup>th</sup> Research Council held on 23.6.2009 vide Resolution no. RC.14.11.2 approved the research proposals alongwith the supervisor mentioned above (**Annexure-1 to item no. 7 as circulated with the agenda**).

Prof. C.B.Sharma, SOE vide his letter dated 24<sup>th</sup> August, 2009 informed that Doctoral Committee of School of Education at its 2<sup>nd</sup> meeting held on 12.8.2009 has appointed Prof. N.K.Dash, SOE as internal supervisor for Ms. Rekha Yadav and Dr. Sutapa Bose as internal supervisor for Mr. K.K.Soman (**Annexure-2 to item no. 7 as circulated with the agenda**) and the same was approved by the Vice Chancellor.

RC 15.7.2 The Research Council ratified the action taken by the Vice Chancellor in approving the Internal Supervisor of Ms. Rekha Yadav and Mr. K.K.Soman, part-time Ph.D candidates seeking admission to Ph.D in Education.

**ITEM NO. 8 To ratify the action taken by the Vice Chancellor in approving the panel of examiners for the evaluation of the Ph.D thesis of Ms. Deepanwita Srivastava, SOSS, Enrolment No. 072676190.**

RC 15.8.1 It was presented that the School of Social Sciences through the Registrar, SED had submitted a panel of examiners for the evaluation of the Ph.D thesis entitled **“France as a Tourist Generating Market for India: A Case Study of Tourist Profiles and Promotional Strategies (1987-2007)** of Ms. Deepanwita Srivastava, Enrolment No. 072676190 (**Anneuxre-1 to item no. 8 as circulated with the agenda**). The Vice Chancellor approved the panel of Examiners for evaluation of thesis.

RC 15.8.2 The Research Council ratified the action taken by the Vice Chancellor in approving the panel of examiners for the evaluation of the Ph.D thesis of Ms. Deepanwita Srivastava, SOSS, Enrolment No. 072676190.

**ITEM NO. 9 To ratify the action taken by the Vice Chancellor in approving the admission to M.Phil programme in Economics.**

RC 15.9.1 It was presented that in accordance with the criteria for admission to M.Phil programme in Economics duly approved by the Vice Chancellor, an Entrance Test (of 100 marks) was conducted followed by an interview (of 100 marks) on 28<sup>th</sup> August, 2009.

On the basis of the performance of the candidates in the written test and in interview, 10 candidates whose names are mentioned in the list placed below have been selected for admission to M.Phil programme in Economics. Further, 2 (two) candidates have also been offered direct admission into M.Phil as they have been qualified NET/JRF conducted by UGC. The list has been duly approved by the Hon'ble Vice Chancellor (**Annexure-1 to item no. 9 as circulated with the agenda**).

RC 15.9.2 The Research Council ratified the action taken by the Vice Chancellor in approving the above candidates for admission to M.Phil programme in Economics.

### **ITEM NO. 10 To consider and approve the Evaluation Methodology for TEE for Ph.D in History (Course Work)**

RC 15.10.1 It was presented that the Evaluation Methodology for Ph.D History courses were approved by the School Board of School of Social Sciences vide Resolution no. SB 44.15(9) and SB 44.15(9) 2 dated November 17, 2008. Subsequently Academic Council approved the same vide its Resolution no. AC 46.27.1 dated January 13, 2009 (**Annexure-1 to item no. 10 as circulated with the agenda**). The details of the same are given below:

#### **COURSES:**

##### **i) RESHIST-1: Historical Method and Historiographical Issues**

- One term paper having 30% weightage to be done by each student.
- The topic of the term paper will be decided by the Course Coordinator.
- Each student will make a presentation of term paper before the faculty.
- The evaluation will be done by the faculty based on the presentation and discussion.
- The term-end examination of two hours duration shall have 70% weightage.
- The Course Coordinator will set the paper and evaluate the answer scripts.

##### **ii) RESHIST-2: Review of Historical Literature**

- Four works of Historical Literature shall be prescribed by the Doctoral Committee for each student and the same shall be notified to the student by the respective supervisor.
- One comprehensive review of 4000-5000 words of all the four shall be written by each student.
- Evaluation, having 100% weightage, of this review shall be done by the faculty, Course Coordinator will organize the evaluation.

### iii) RESHIST-3: Study of Source Material

- Selections from primary sources shall be prescribed by the Doctoral Committee for each student and the same shall be notified to the student by the respective supervisor.
- One comprehensive essay of nearly 4000 words on all the selections shall be written by each student.
- Evaluation, having 100% weightage, of this essay shall be done by the faculty. Course Coordinator will organize the evaluation.

### iv) RESHIST-4: Interdisciplinary Encounters

- One term paper having 30% weightage to be done by each student.
- The topic of the term paper will be decided by the Course Coordinator.
- Each student will make a presentation of term paper before the faculty.
- The evaluation will be done by the faculty based on the presentation and discussion.
- The term-end examination of two hours duration shall have 70% weightage.
- The Course Coordinator will set the paper and evaluate the answer scripts.

RC 15.10.2 The Research Council considered and approved the Evaluation Methodology for TEE for Ph.D in History, SOSS.

**ITEM NO. 11 To consider and approve the admission to the Ph.D candidates of NET (UGC) in Mathematics discipline.**

RC 15.11.1 It was presented that an Entrance Test for admission to Ph.D in Mathematics was conducted on 14<sup>th</sup> September, 2009 at School of Sciences. Out of 14 candidates only 1 candidate namely Ms. Seema Saxena appeared in the Entrance Test and could not qualify under the Category “B”.

A meeting of the Doctoral Committee was held for the selection of candidates under category A and B on 15<sup>th</sup> September, 2009 at School of Sciences, IGNOU. The Committee recommended two candidates who have

qualified NET/GATE for admission in to Ph.D Mathematics. They are:

1. **Mr. Navin Kumar Sharma**
2. **Mr. Nitin Mishra**

The Doctoral Committee recommended the above two names subject to clearing courses RMT-001 to RMT-004 and any two courses from the optionals RMTE-005 to RMTE-010. The committee also recommended that registration of above two candidates may be given only after clearance of coursework (**Annexure-1 to item no. 11 as circulated with the agenda**). In the same Doctoral Committee meeting held on 15<sup>th</sup> September, 2009 Ph.D applications under Category “A” were also considered. Based on the interaction with the candidates, the committee found none suitable based on their Ph.D proposals and presentations.

RC 15.11.2 The Research Council considered and approved the admission for Ph.D. in Mathematics for the above two candidates (who qualified UGC- NET). The registration will be offered only after clearance of the Course Work.

**ITEM NO. 12 To ratify the action taken by the Vice Chancellor in approving the names of the external research supervisors for the School of Engineering and Technology (SOET).**

RC 15.12.1 It was presented that the School of Engineering and Technology has submitted the following names of external research supervisors for the candidates pursuing Doctoral Programmes from SOET:

RC 15.12.2 The Research Council ratified the action taken by the Vice Chancellor in approving the above three names of the external research supervisors for School of Engineering and Technology (SOET).

**ITEM NO. 13 To consider and approve the admission of Shri Lalkhwangalha part-time candidate for Ph.D in Rural Development (SOCE).**

RC 15.13.1 It was presented that a Doctoral Committee meeting for Ph.D in Rural Development was held on 23.7.2009 at School of Continuing Education to consider the candidature of Shri Lalkhwangaiha, a part-time candidate for admission into Ph.D in Rural Development. The Doctoral Committee while considering the research proposal has recommended the following:

1. The Committee examined the C.V of Dr. Lalnilawama, Department of Extension Education and Rural Development, Mizoram University, P.O Box 190, Aizawl-796009, Mizoram (Phone: 0389-2330221 (office); 91-9436143465 (Mobile), e-mail: nilawm@yahoo.com) and found him suitable to be recommended for approval as Supervisor.
2. Since the candidate has an M.Phil in Political Sciences and also M.A (RD), he can be exempted from three compulsory courses, but may have to submit two papers.
3. The revised proposal is definitely an improved version and has taken into consideration most of the suggestions given by the Doctoral Committee earlier.
4. The context of the study has been specified and articulated much better. Further, the objectives of the proposed research have been reformulated in a clearer and sharper fashion and the revised work plan shows a substantial improvement over the earlier one.
5. However, the proposal can be made more useful and relevant if the following suggestions are incorporated before taking up the research:
  - The research methodology needs to be further sharpened. It was felt that instead of making it a micro study focusing only on administration of these two programmes it will be useful if its scope is left open to study socio-economic impact, which can then enable a comparative analysis with other similar areas in Mizoram/North East in order to draw relevant inferences.
  - The researcher should also make use of all existing secondary data for North-Eastern Region which is relevant to the chosen programmes.
  - Since the programmes are revamped/modified from time to time, the Researcher may focus more on qualitative aspects of these programmes such as organizing self-help groups, impact of shelter and their relevance to socio-economic upliftment of rural areas.
  - The Researcher may also consider studying such programme which are not likely to be immediately revamped/withdrawn so that the process of study does not hamper. The scope of the research will be broadened to include new programmes which are in continuity with the programmes which were intended to be studied.

The Minutes of the Doctoral Committee were approved by the 39<sup>th</sup> School Board of SOCE held on 27<sup>th</sup> July, 2009 (**Anneuxre-1 to item no. 13 as circulated with the agenda**).

RC 15.13.2 The Research Council observed that the topic of the research proposal is not mentioned in the Minutes of the Doctoral Committee. Similarly, the School Board did not mention about the approval of the research guide for guiding the candidates.

RC 15.13.3 The Research Council considered the above but could not approve the Ph.D registration of Shri Lalkhwangalha due to the reasons stated above.

**ITEM NO. 14 To consider and approve the names of the faculty/ professionals from IGNOU and other than IGNOU for Research Supervisorship.**

RC 15.14.1 It was presented that Research Unit has received curriculum vitae from different faculty/ professionals of IGNOU as well as other than IGNOU requesting to consider their names for the research supervisorship for Ph.D/M.Phil programmes of IGNOU. Curriculum vitae of faculty/professionals received were circulated among the members of the Research Council.

RC 15.14.2 The Research Council considered and directed the Director, Research to forward curriculum vitae of the above faculty (from IGNOU as well as other than IGNOU) to the School concerned for their action.

**ITEM NO. 15 To consider and approve the recognition of CSI College of Education, Madurai as a Research Centre of IGNOU.**

RC 15.15.1 It was presented that the Vice Chancellor had constituted a committee consisting the following members to examine the request received from the Director, Centre for Educational Research and Development, CSI Institutional Campus, Pasumalai, Madurai to recognize their institution as a Research Centre of IGNOU for Education. The members of the committee are:

The Committee visited the CSI College of Education, Madurai on 18.9.2009 and assessed academic and physical facilities available with the institution for conducting research activities in Education.

The Committee in principle recommended the recognition of CSI College of Education, Madurai as a Research Centre of IGNOU. Further, the Committee also recommended some minor improvements to be done by the CSI College of Education. The suggested improvements are:

- 1 Adding about 6-10 important foreign journals for reference.
- 2 Acquiring renowned reference research volumes (ex: Encyclopedia of Educational Research, Dictionary of Psychology, leading National & International journals together with important publications by reputed international/foreign authors like Viersma).
- 3 Start a Centre for providing special training to students with learning disabilities, teachers, parents and other stakeholders, bring out a research journal on the “Learning Disability Studies”.
- 4 Develop an extension centre for training of primary/secondary teachers/ teacher educators for conducting/organizing specialized professional practices in dealing with students with Learning Disabilities.
- 5 Develop/create a website on “The Learning Disabilities: The Indian Context”
- 6 Develop research tolls, aids and appliances for doing research studies in different aspects under the area of Learning Disabilities.

The Committee also recommended that a Research Committee be setup by the IGNOU of six members – three from the Centre and three from the IGNOU to act as a supervisory body which will screen research proposals received each year.

RC 15.15.2 Prof. M.L.Koul, Director, SOE and who have visited CSI College of Education, Madurai explained the various quarries raised by the members.

RC 15.15.3 The Research Council considered and approved the recognition of CSI College of Education, Madurai as a Research Centre of IGNOU.

**ITEM NO. 16 To ratify the action taken by the Vice Chancellor in approving the names for admission into Ph.D in Economics.**

RC 15.16.1 It was presented that the discipline of Economics had received 25 applications for Ph.D in Economics. The discipline had conducted an Entrance Examination (duration of 3 hours) on 28<sup>th</sup> August, 2009 wherein 13 candidates were appeared. Those who secured 35 or more marks out of total 100 were short-listed for interview/presentation of synopsis before the Doctoral Committee of Economics discipline.

The Doctoral Committee meeting was held on 29.9.2009 and five (05) short-listed candidates were invited for presentation. Further, the discipline of Economics (SOSS) has also invited two of the old research proposals (applications submitted for the previous cycle) for presentation. The names of the selected candidates for Ph.D. in Economics are:

Further, the Research Council mentioned that the School Board should clearly specify that research supervisor(s) assigned/allotted to candidates are approved by the School Boards.

RC 15.16.3 Prof. Gopinath Pradhan, Ph.D Programme Coordinator, Economics explained that the Faculty of Economics would allot supervisors for candidates soon for whom supervisors not assigned.

RC 15.16.4 The Research Council considered and approved the registration of above candidates for Ph.D in Economics with a condition that the Faculty of Economics and School would allot research supervisors soon subject to placing the same before the School Board and subsequently before the Research Council.

**ITEM NO. 17 To ratify the action taken by the Vice Chancellor in approving the Ph.D registration in Women Studies (SOGDS).**

RC 15.17.1 It was presented that the Academic Committee of the Women Studies, SOGDS scrutinized applications received for the Ph.D and recommended 06 candidates for interview/presentation of Ph.D proposals in Women's Studies. Selected candidates were invited to present their proposals before the Doctoral Committee held on 31.8.2009 in the School of Gender and Development Studies.

Out of 06 candidates invited, only 04 appeared and made presentations. Out of four, Ms. S. Sreerekha and Ms. Mini Sukumar were selected for Ph.D in Women Studies. The details are placed below:

**Ms. S.Sreerekha**

Title of the proposal: "Honorary Care Workers: Anganwadies and the Indian States"

**Ms. Mini Sukumar**

Title of the proposal: "Gender Model: Discussing the Gender Development Interface of decentralization in Kerala".

The Committee also recommended the following feedback to incorporate into the research proposal:

- (a) Proposal could be expanded into exploration of the machinery of “centralized decentralization” through a gender lens.
- (b) A comparative approach inclusive of both women’s and men’s perspectives and situations would also be useful in making the research more comprehensive and meaningful.
- (c) Candidate may be required to take one semester of on-campus Course Work (including the Research Methodology course) as part of the Course Work requirement.

Research Guides for both the candidates are yet to be identified/recommended by the Doctoral Committee.

The Doctoral Committee has recommended Ms. S.Sreerekha as well as Ms. Mini Sukumar names for Ph.D registration in Women Studies. The Minutes of the Doctoral Committee dated 31.8.2009 and approval of the Vice Chancellor dated 30.8.2009 was placed at **Annexure-1 to item no. 17 as circulated with the agenda.** Minutes of the above Doctoral Committee will be placed before the forthcoming School Board of the SOGDS for ratification.

RC 15.17.2 The Research Council observed that the names of research supervisors are not mentioned in the Doctoral Committee/School Board’s Minutes.

RC 15.17.3 The Research Council considered and approved the registration of above candidates for Ph.D in Women Studies with a condition that the Faculty and School would allot research supervisors soon subject to placing the same before the School Board and subsequently before the Research Council.

**ITEM NO. 18 To ratify the action taken by the Vice Chancellor in approving the shifting of Ms. Pragya Dubey, RTA from SOCE to SOGDS.**

RC 15.18.1 It was presented that based on the request received from Ms. Pragya Dubey, RTA, School of Continuing Education, a proposal was moved for shifting of Ms. Pragya Dubey, RTA from School of Continuing Education (SOCE) to School of Gender and Development Studies (SOGDS). Respective Directors of the concerned schools have agreed for shifting Ms. Pragya Dubey from SOCE to SOGDS. Hon’ble Vice Chancellor had approved the same. RC 15.18.2 The Research Council ratified the action taken by the Vice Chancellor in approving the shifting of Ms. Pragya Dubey, RTA from SOCE to SOGDS.

**Eligibility:** The Research Programme (Ph.D) in French language will be open to students belonging to both categories A & B.

**Category A:** All those having an M.Phil. Degree/teaching experience/industry experience of 5 years or more.

**Minimum Duration** 2 years

**Category B:** All Post Graduates fulfilling requirements of specific competence levels in the language.

**Minimum Duration** 1 year Course Work\* + 2 years  
(\*This would include an introduction to theoretical concepts and research methodology)

To finalize course content and overall curriculum, the SOFL will be holding the Experts Committee meeting at the earliest. The Minutes of the 3<sup>rd</sup> School Board Meeting of SOFL was also annexed.

RC 15.31.1 It was presented that the Doctoral Committee for the Ph.D programme in Vocational Education and training in its meeting held on October 07, 2009 has made the following recommendations on eligibility criteria for Ph.D in Vocational Education and Training:

**Category “A”:** Candidates having Post Graduate Degree in any discipline from any recognized higher learning institution with 5 years teaching/industry/professional experience in the relevant vocational area. Candidates are required to submit a proposal alongwith application.

**Category “B”:** Candidates having a post graduate degree in any discipline from any recognized higher learning institution would be required to:

- Submit an essay (write up) of about 500 words stating his/her interest to join Ph.D programme on the particular vocation. What has motivated him/her to undertake the research in this area and how the research work will help him/her in the profession (10%) weightage.

Based on the qualifications and the essay the applications will be shortlisted by the School.

- An entrance test will be conducted by the University to test the aptitude for the Vocational Education and Training (60% weightage) for the shortlisted candidates.

- The final selection of the candidates will be recommended by the Doctoral Committee of the discipline after interviewing (30% weightage) the candidates who have cleared the entrance test.

The selected candidates have to complete 32-36 credits of course work as recommended by the Expert Committee.

The salient features of the qualifications and the process of admission were placed at **Annexure-1 to item no. 31 as circulated with the agenda.**

The School Board of School of Vocational Education and Training has approved the recommendations of the Doctoral Committee's recommendations in its meeting held on October 15, 2009. The extracts of the minutes of the School Board were also placed at **Annexure-2 to item no. 31 as circulated with the agenda.** The School will initially offer the programme only for those having relevant experience under category 'A'. Under Category 'B', the School will offer Ph.D/M.Phil programme to fresh candidates after developing 32-36 credits of course work.
